

## Federal Infrastructure Package Update

**UPCOMING EVENTS** 

**ONGOING MEETINGS:** 

The U.S. House of Representatives passed the \$500 billion Bipartisan Infrastructure Framework, which now goes to President Biden's desk. The House also approved a rule to begin formal debate on the amended version of the Build Back Better (BBB) reconciliation legislation, which would address the nation's affordable housing crisis by investing nearly \$12 billion in the Housing Credit. The BBB legislation could be voted on next week after the Veterans Day recess and includes the following tax credit improvements:

 Lowering the bond-financing threshold from 50 percent to 25 percent for five years,

 Increasing the annual Housing Credit allocation at a rate of 10 percent per year plus inflation from 2022 to 2024, and

 Providing a permanent 50 percent basis boost for properties serving extremely low-income (ELI) households, along with an 8 percent minimum set-aside for properties taking advantage of the ELI basis boost.

#### Member Spotlight: Southway Builders DEI Initiatives Underway

At Southway Builders, Diversity, Equity, and Inclusion (DEI) are imperative and a top priority. Why? Simply put, we strive to continually improve and want to be a better mirror of the community in which we live and work. The construction management industry has historically been overwhelmingly white male-dominated, and we know that a diverse workforce with varying life experiences, education, race, age, sexual orientation, culture, and other variables that influence personal perspectives provides the opportunity for a high quality and all-around better business.

Our process started at the top with our president, where his motivation to make DEI a top priority led to the creation of a committee to oversee the initiative. That group spoke with 10 consultants before selecting The Wells Collective (TWC) as the best organization to lay the foundation for our effort. We engaged them to conduct three introductory, mandatory for all Southway employees, training sessions - Bias 101 (two hours), Equity and Anti-Racism (three hours), and Systemic Racism & Housing in the U.S. (three hours). We offered three classes on each topic to allow flexibility for our employees' schedules. Having now completed those three sessions, our next effort is for TWC to conduct a company-wide survey to check our current pulse on equity and belonging in the workplace. The results from this audit will allow us to examine our existing culture, policies, and procedures using an equity lens to formulate an intentional path forward. This imitative is unique in that

## Annual Meeting Recap

Over 200 members joined us on October 19, 2021 for the virtual MAHC Annual Meeting where we celebrated the 10<sup>th</sup> Anniversary and 100<sup>th</sup> closing for the Rental Housing Works Program. Hollander Ridge (NHP Foundation) and Homes on Quaker Lane (Homes for America) both received the Innovation Award.

DHCD Secretary Ken Holt presented MAHC with a Citation from Governor Hogan in celebration of the 100<sup>th</sup> Closing for Rental Housing Works! He also highlighted the many programs the Department has been administering to assist renters, homeowners, and businesses impacted by COVID and to help the State's economy recover. He announced that the draft QAP would be out in the very near future, with the final Plan to be approved by year end and a Round in the 1Q of 2022.

David Gasson also gave an update on what is happening on Capital Hill. He had a lot of good news to share, including that on the tax side our industry is in a good place with many proposed tax credit improvements included in the BBB bill. PBRA. There is also separate legislation to amend some of the LIHTC provisions in Section 42i7, removing exit taxes and changing the ROFR to a purchase option for future LIHTC deals. He was very hopeful that the LIHTC improvements would make it into the final BBB bill and that the Infrastructure bill would include funding increases for affordable housing programs.
